The PUPPY: A purebred BEAGLE (breed) PUPPY, bred by the BREEDER, from a current or future litter, of either gender and any color, with NO BREEDING RIGHTS and eligible for either AKC limited or UKC registration (non-breeding papers) of the BREEDER's choice after the BREEDER receives proof of spay/neuter from the BUYER.

The Terms:

1. The BUYER agrees to pay the BREEDER a non-refundable Reservation Fee of \$300 (Three Hundred Dollars) by PayPal invoice, Zelle, or USPS Money Order; as a service fee for the BREEDER's service of holding and reserving a place on the BREEDER's "Waiting List" for a PUPPY, for the BUYER to purchase, within 365 days (one year) of the date of this contract.
2. The Reservation Fee (service fee) will be applied towards the purchase price of a PUPPY from the BREEDER within the next 365 days (one year).
3. The Reservation Fee of \$300 will be applied to the purchase price of a PUPPY. The BUYER agrees to pay the BREEDER the remaining balance in CASH at pickup.
4. The BUYER must select/choose and pickup a PUPPY from the BREEDER within 365 days (one year) of the date of this contract. This \$300 reservation fee will expire and be kept by the BREEDER with no further obligation to the BUYER in 365 days (date listed above).
5. The PUPPY will be sold only for the purpose of a **Pet (Companion Animal)**. While the PUPPY may be capable of performing other functions, no warranty will be given as to its fitness for any other purpose than as a Pet. The PUPPY will be sold as a **PET with NO BREEDING RIGHTS** and **non-breeding registration papers**. The BREEDER will provide the BUYER with **either AKC Limited or UKC Registration (non-breeding papers), of the BREEDER's choosing after receiving proof from the BUYER that the PUPPY has been spayed/neutered by a licensed Veterinarian.**
6. The BUYER will select/choose from BOTH GENDERS (male & female) and ALL COLORS of PUPPIES bred by the BREEDER (except for any PUPPY that the BREEDER keeps for themselves) in the order that they joined the BREEDER's "Waiting List" based on the date that the \$300 reservation fee AND the signed Puppy Reservation Contract is received by the BREEDER.
7. When it is the BUYER's turn on the "Waiting List" to select/choose/skip a PUPPY, the BREEDER will notify the BUYER by text and email. If the BUYER does not respond within 24 hours, the BREEDER will "skip" the BUYER's selection/choice until the next litter becomes available for the BUYER to select/choose/skip a PUPPY from.
8. The BUYER understands that the BREEDER does not offer shipping or transportation for Puppies. The BUYER agrees to pick up their PUPPY in person (only the BUYER(s) on this contract can pick up the

PUPPY, no representatives) at the BREEDER's address on the date or within the following 7 days of the date that the PUPPY turns 8 weeks old.

9. The BUYER has read the BREEDER's terms and "Puppy Sales Contract". The BUYER agrees to the BREEDER's terms, conditions, and policies.
10. All parties, without any emotional or mental reservations whatsoever, are freely entering into this contract.
11. Contract and guarantees are only implied between the BREEDER, and the original BUYER, NOT to a third party. This contract and guarantees are not transferable.
12. The BREEDER reserves the right to cancel the sale, issue a refund, and not sell the PUPPY to the BUYER for any reason and at any time prior to the PUPPY leaving the BREEDER's possession.
13. This is a legally binding contract, controlled by the laws of South Carolina. It is agreed that if there are any disagreements between the BREEDER and the BUYER, that they will be settled in Berkeley County, South Carolina.
14. Any costs of litigation will be paid for by the BUYER.

The written terms of this contract contains the entire agreement between the BREEDER and the BUYER. No other written, verbal, or implied statements, promises, documents, or writings shall have any effect on this contract unless these terms are reduced to writing, signed by both parties, and attached.
